## Doctors' Office Visits

- If you need to see a doctor or specialist, simply visit <u>www.MultiPlan.com</u> and search for the "physician only network"
- Select an in-network provider, and when you make the appointment if they ask "What kind of insurance do you have?" tell them your plan uses the PHCS physician only network.
- Present your benefits wallet card when you get to the doctor's office

# Inpatient or Outpatient Surgery or Procedure

- If you need to go for an outpatient surgery or procedure, always contact MediBid first.
- You can also post a request at <u>HTTPS://ElectricMirror.MediBid.com</u>
- Or you can email <u>ElectricMirror@MediBid.com</u> or call 1-888-855-6334
- Make sure to give as much detail as possible, and upload any imaging studies or notes to the secure portal
- IF you are admitted without doing this first, contact us as soon as possible and preferable WHILE you are still in the hospital
